

MINUTES OF THE SPECIAL MEETING OF THE BOARD OF PUBLIC WORKS  
OF THE CITY OF AUBURN, NEMAHA COUNTY, NEBRASKA  
HELD  
JULY 25, 2006

THE BOARD OF PUBLIC WORKS OF THE CITY OF AUBURN, NEMAHA COUNTY, NEBRASKA, met in special session on the 25th day of July 2006 at the regular meeting place of the Board at the hour of 12:30 P.M. Said meeting being held in open session as required by Chapter 84, Article 14 of Nebraska Statutes.

Chairman Grant called the meeting to order.

Chairman Grant requested roll call: members present - Glenn, Grant, Humphrey, Schneider; absent - Hamilton.

Purpose of the meeting being: 1) Discussion/Action - General Manager Search (time allotted for Closed Session) and 2) Discussion/Action - Water Supply Considerations (time allotted for Closed Session).

1) Concerning General Manager Position: Interview with a prospective candidate for the position had been scheduled and, following the interview, a telephone conference with the recruitment firm. At 12:30 P.M., motion was moved by Member Humphrey, seconded by Member Schneider, the Board go into closed session for the purpose of conducting the interview and evaluation of prospective candidate. Roll call: those voting aye - Glenn, Humphrey, Schneider, Grant. Chairman Grant declared the motion carried. Chairman Grant stated the purpose for the closed session. Chairman Grant declared the meeting reconvened at 2:20 P.M. No action was taken. The Board will continue with the process. The Board will conduct the next personal interview with another candidate on July 26, 2006.

2) Concerning Water Supply Considerations: The Board briefly discussed the water supply issues but no action was taken and the Board did not go into closed session.

There being no further business to come before the Board, motion was moved by Member Glenn to adjourn to special meetings of the Board to be held Wednesday & Thursday - July 26 & 27, 2006 at the hour of 12:30 P.M. at the regular meeting place of the Board. Member Schneider seconded the motion. Roll call: those voting aye: Glenn, Humphrey, Schneider, Grant. Chairman Grant declared the meeting adjourned. Agenda items will be posted.
